6. The Committee will be responsible for Consultancy activities related to R&D.


7. The Committee will be responsible for ensuring the provision of research and development opportunities for academic staff to maintain enthusiasm, awareness and relevance in teaching and other Institutional activities.
8. The development of infrastructure conducive to promoting the quality and quantity of research and development.
9. The establishment of research and development priorities; and monitoring the quality and quantity of research and development.
10. Monitor the application of Research Funds to ensure that the funds are properly and formally accounted for.
11. Promote emerging areas of research and development.
12. Development of mechanisms conducive to the best possible ways of engaging and motivating the Faculty Members & to foster the development of multi-disciplinary research endeavors across departments.
13. The quality of postgraduate education to be brought up to an internationally high level. An evaluation of PG program to be carried out by the R&D committee time to time.
14. To promote building strategic, durable partnerships and develop funding solutions with Industries and research Institutions for steering, funding and cooperation.
15. Submit Half Yearly report to the HOI pertaining to publications, patents, projects and other related activities.
16. Maintain suitable documentation process for all the R&D Activities of the Institute.

**Meetings:** At least twice per semester and as and when deemed fit by the Committee.
